Coaches and Athletics Directors,

Thank you for your interest in Redlands East Valley Wrestling's Girls Varsity or Boys Junior Varsity Tournament, the contracts for those tournaments can be found on the following pages. Each year we fill up and unfortunately have to turn teams down. Each year it also seems a team will show up without a contract or spot in the tournament. Additionally, every year I get checks in the mail from teams that have not sent a contract and do have a spot in the tournament. To help us continue to run a smooth tournament and avoid these problems please follow the instructions in this letter carefully to ensure your spot.

1. All contracts must be sent to the Head Coach, once the head coach confirms your entry he will pass them on to Redlands East Valley's athletic department to sign and return to you.
2. **You are not in the tournament until you receive confirmation from the head coach, Bryan Holcombe, that he has received your contract.** If you have sent the contract over and not received confirmation feel free to reach out via phone or email, contact information is below. Sending a check does not guarantee your spot.
3. The preferred method and easiest way to secure your spot is sending the contract via Email to the Head Coach. We cannot hold spots without contracts.

Finally, our max bracket size will be 24 wrestlers per weight class. One wrestler per weight class per team is guaranteed and then we will get as many "B" or "C" wrestlers as possible to fill those brackets. Teams that have payment in or with them for those extras and prior notification of multiple teams will receive priority when filling those brackets out.
